Sl. No.	The school is directed to ensure that :
1	The total number of sections of the school shall be restricted to 12 as per the number of sections reported during inspection and further increase of sections shall be subject to specific approval of the Board on the basis of the request of the school as per affiliation bye law.
2	Some of the part of the front wall of the school is less than 6ft of height and covered with iron grill. Thus, the school is required to replace the same with the pucca concrete boundary wall and ensure school should be bounded from all sides with minimum 6 ft of height within 03 months and submit the compliance.
3	Name of the lessor has not been mentioned in the land certificate. Thus, the school is directed to submit the revised land certificate as per format (appendix – X) with complete details within 3 months and submit the compliance.
4	The library is seen as under stocked.The school shall upgrade the same and make the separate reading space for staff in the library as per soP issued by the Board, within 3 months and submit the compliance on SARAS.
5	No storage space is seen in the library. Exhaust fans, fire extinguishers are not seen.the school shall upgrade the composite science lab as per SoP of the Board within 3 months and submit compliance on SARAS.

6	CWSN toilets are seen only at ground floor. The school is directed to remove the temporary frame from the WC which is not as per norms and affix support bars on the walls. the CWSN girls toilet is very small with no space for wheelchair/walker to navigate, unlike the boys CWSN toilet which has sufficient space and sliding door. The toilet are needs better maintenance. The school shall construct separate toilets for CWSn, boys and girls on every floor with proper permanent signage indicating the floor number, as per norms of RPwD Act and guidelines issued by the Board within 3 months and submit compliance on SARAS.
7	Failure to submit compliance on the above mentioned points within the prescribed time shall invite financial penalty against the school.
8	The school shall conduct training of its teachers with CoE Patna within 3 months and submit the compliance.
9	The school shall follow the SoPs issued by the Board in respect of labs, library and sports facilities.
10	The school shall not remove the videography links in the mandatory disclosure section of its website and renew all mandatory certificates from time to time

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ Rs. 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII , as the case may be.

The approval of the Board as mentioned above, is subject to the following conditions:-

1. The school shall be responsible for its genuineness of the documents/ data/ information uploaded by the school. In case of any discrepancies, action will be initiated against the school as per Affiliation Bye -Laws-2018.
2. The school shall follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State /UT Govt. from time to time. The school will also abide by the conditions prescribed, if any, by the State Government concerned.
3. The School shall apply online for extension of affiliation along with the requisite fee and other documents as per Rule 10.3 of Affiliation Bye Laws.
4. The school shall go through the provision of Affiliation and Examination Bye Laws and subsequent amendment therein as well as circulars and guidelines /instructions issued by the Board time to time and keep a copy thereof for reference purpose and is also advised to regularly visit CBSE websites i.e., <http://cbseacademic.nic.in/> & <http://cbse.nic.in/> for updates.
5. The school shall renew mandatory certificates from time to time.
6. The school shall be solely responsible for any legal consequences arising out of the use of school name/logo/society/trust or any other identity /activity related to running of school affiliated to CBSE. All legal expenses incurred by the Board, if any, arising out of these circumstances, shall be borne by the school.
7. Concerned Regional Office is requested to create new email id of school as per direction issued by controller of examination. This E Mail ID is used for communication with CBSE only.
8. The school shall not remove the documents and videography links in the mandatory disclosure section of its website.
